Twelve NBWA board members attended the meeting comprised of 26-member agency staff, stakeholders, partners, and interested members of the public. Meeting participants attended inperson and remotely via Zoom.

- 1. Welcome and Call to Order Roll Call and Introductions Chair Mariani called the meeting to order at 9:34 am and took roll call.
- 2. General Public Comment None
- 3. **Agenda and Past Meeting Minutes Review** Chair Mariani asked for any Board members to speak up if there were requested changes to the agenda. No comments. None opposed—Unanimously approved.

Chair Mariani asked if there were any changes or corrections to the minutes for the August 30 Board meeting. No comments. None opposed—Unanimously approved.

Treasurer's Report

No comments on the July1 to September 30, 2024 Treasurer's Reports. Director Garcia moved to approve the June Treasurer's Report; Director Patterson moved. Director Clark seconded—Unanimously accepted.

4. Guest Presentation – The incredible (and incredibly colorful) history of Mare Island Kent Fortner, President of the Board of Directors of the Mare Island Historic Park Foundation and Founder of Mare Island Brewing Co.

Kent provided a rapid-fire slideshow of the incredible (and incredibly colorful and impactful) history of Mare Island, starting with the planting of a flagpole in 1954, its strategic location for shipbuilding, and its deep-water channel that allowed the construction and deployment of ships. He shared stories about the USS Saginaw, the first ship built on the island, and its shipwreck. Kent also recounted an encounter with William Halford's descendant and the naming of their first beer, Saginaw Gold Nail. He highlighted the island's features, including refurbished coal sheds, dry docks, and ammunition bunkers, and mentioned its role in aircraft carrier development and submarine construction during World War II. Kent shared his personal experience of restoring a 1916 officers' quarters house on the island and his involvement with the local historic foundation.

Kent discussed the historical significance of the Mare Island Naval Shipyard, particularly its role in World War II and the construction of the atomic bomb. He shared the tragic story of the USS Indianapolis, which delivered the bomb's parts and was stationed on the island, and the subsequent survival of 800 sailors. Kent also mentioned the restoration of the island's flagpole and the National Park Service's plans to bring historic ships to the island.

5. Guest Presentation – Mare Island Infrastructure Assessment (MIIA) Project Overview Anne Girtz, PE, Senior Engineer, West Yost

Anne presented assessment highlights from the Mare Island infrastructure assessment project which covered the water, sanitary sewer, storm drainage and flood control, roads, and dry utility systems on Mare Island.

Anne discussed a project assessing the infrastructure systems on Mare Island, focusing on water, sewer, and storm systems. The project, initiated in November 2022, involved various desktop and field evaluations, with results presented to the client team. A public open house was held in September, and preliminary results and a report are currently being presented to the city and board. The project is grant-funded, with additional work identified, leading to a request for an extension. The project involved multiple stakeholders, including the City of Vallejo, City of Vallejo Water Department, City of Vallejo Public Works Department, Vallejo Flood & Wastewater District, and Mare Island Company. The project's scope included assessing the condition of the existing infrastructure and determining necessary improvements to serve current and future needs. Anne also discussed the condition and seismic assessment of water tanks and pipelines on the islands, the testing of critical pipelines, and the flow monitoring and analysis of the sanitary sewer system. She highlighted the need for improving the pipelines to reduce inflow and infiltration. Anne also discussed the assessments conducted on the storm drainage and sea level rise, the need for improvements such as storm drains or sea walls to accommodate this rise, and the seawalls that run from the finger piers in the south to the causeway in the north. The City is seeking an extension for additional funding for the seawall and sewer system work, and Mare Island Company will use the information for their planning work and infrastructure planning.

Anne presented the project's findings and recommendations, emphasizing the need for additional assessments and future funding.

6. Guest Presentation - Overview of Russian River Watershed Pilot Project

Chris Delaney, Principal Engineer, Sonoma Water

Chris Delaney gave a brief talk on the Russian River Watershed Resilience Project. This past July, Sonoma Water received a 2-million-dollar grant award from the California Department of Water Resources to develop a climate resilience plan for the Russian River Watershed by April 2026. Chris's talk covered the major project tasks and the anticipated outcomes. Chris discussed the Watershed Resilience Pilot Project, a DWR program focused on climate change resilience planning at the watershed scale for the Russian River region. The project involves setting the stage, exploring climate hazards, assessing vulnerabilities and risks, developing adaptation strategies, and implementation and monitoring, with a strong emphasis on equity and inclusivity.
